
Directions to CCSU

Keynote Speaker

Alice Bonner, PhD, RN, FAANP, Director, **Division of Nursing Homes, Centers for** Medicare and Medicaid Services has been a geriatric nurse practitioner for the past twenty years. From 2009 to 2011 Alice Bonner was the Director of the Bureau of Health Care Safety and Quality at the Massachusetts Department of Public Health in Boston, Massachusetts. From 2005 to 2009 Dr. Bonner was Executive Director of the Massachusetts Senior Care Foundation, an organization that works to improve the quality of long term care services to the state's older adults and people with disabilities through education, research and quality improvement programs. Alice Bonner is also an Assistant Professor at the Graduate School of Nursing, University of

Massachusetts in Worcester, MA. From 1997 to 2005 she was the Clinical Director of Long Term Care and Geriatrics at the Fallon Clinic in Worcester, Massachusetts. Alice Bonner's research interests include improving nursing home quality, patient safety culture in health care organizations, safe medication prescribing and management, fall prevention and improving care transitions across settings.

Speakers

Amy Boutwell, M.D., M.P.P. is the founder of Collaborative Healthcare Strategies which was established to pursue work aligned with the opportunities created by the Affordable Care Act, the CMS Center for Innovation and the Partnership for Patients, specifically with the goal of engaging thousands of communities across the nation to work across settings and sectors to improve healthcare delivery. Dr. Boutwell is also the co-founder of the STAAR Initiative (State Action on Avoidable Rehospitalizations) of the Institute for Healthcare Improvement (IHI). Since 2008 Dr. Boutwell has been deeply immersed in the clinical, operational, policy, payment and political aspects of approaches to reduce avoidable rehospitalizations and improve care transitions. As a result of her work. Dr. Boutwell has served as an expert panelist and advisor to CMS, the National Governor's Association and the Academy Health State Quality Improvement Institute. Dr. Boutwell serves as a senior physician consultant to the National Coordinating Center for the CMS QIO Care Transitions Theme and is engaged in community-based care transitions mobilization efforts in all fifty states Dr. Boutwell is a graduate of Stanford University, Brown University School of Medicine and the Harvard Kennedy School of Government, where she received a master's degree in public policy and the Robert F. Kennedy Award for Excellence in Public Service. Dr. Boutwell is a

practicing physician at Newton-Wellesley Hospital and an Instructor in Medicine at Harvard Medical School.

Ann Spenard, MSN, RN, C, is Vice President for Operations at Qualidigm, a consulting company whose mission is to advance the quality, safety and costeffectiveness of healthcare. Ms. Spenard has twenty-three years of experience as a longterm care and geriatrics specialist, surveying for the Joint Commission for several years in hospital and long-term care settings. Ms. Spenard has worked on national initiatives related to MDS 3.0, providing education nationally and is a TeamSTEPPS Master Trainer, providing education to Connecticut's hospitals. Ann Spenard joined Qualidigm in 2005, having formerly served as a consultant there while she was President of Healthcare Consultation and Educational Resources, a company she founded. As Vice President of Program Operations at Qualidigm, Ann is responsible for directing initiatives including those that are for Qualidigm's contract with CMS. In her nursing career Ann spent many years in the Emergency Department and was subsequently a compliance coordinator in long-term care and a Director of Nursing.

Denise Boudreau-Scott, MHA, LNHA, a

licensed nursing home administrator in the states of Connecticut and New Jersey, currently serves as a coach and mentor to healthcare organizations to enable them to inspire and empower stakeholders including staff, residents and family members to improve quality of care and quality of life. Ms. Boudreau-Scott is a Co-Founder of the New Jersey Alliance for Culture Change and for the past six years has worked throughout North America with Planetree on personcentered care. Ms. Boudreau-Scott received a Bachelor of Science in Gerontology from the University of Scranton and a Masters of Health Administration from Cornell University. Ms. Boudreau-Scott has been a speaker at state and national conferences on topics related to resident-centered care.
